Mayor Cox mentioned pedophile notifications. We have not received one on quite a while. Trustee Snyder stated that Sargent Rapp is the Police Officer who handles these concerns. Trustee Morgan asked who do we get these from now? Mayor Cox answered, the Police Chief.

Trustee Snyder stated there will be a speed wagon set-up at the corner of Sanford Drive and Vermont Street in the near future. Once in place statistics/data will be provided to the Village Board through the Nunda Police Department.
