Mayor Cox called the meeting to order at 7:00 P.M.

Visitor's Forum

The Mayor recognized and welcomed all visitors to the meeting this evening.

Sue Carpenter – presented her current water/sewer bill to the Board and wanted an explanation as to why she was now being charged two water and sewer units.

Mayor Cox asked Clerk-Treasurer Wood to explain why there were changes to her bill at this time. It was explained to the customer that a thorough audit of all water/sewer customer was completed in February 2016 per Village Local Law No. 1-2004 Water Rules and Regulation. It was determined at that time that the residence in question does have two living units. The owner explained that more than ten years ago when one water meter was placed at that the property it was then considered one location and that they should only be charged one water and one sewer unit, per the customer's recollection of what the former Chief Water Operator communicated to them.

Questions asked to the customer from the Board were about how many kitchens and bathrooms are at the property. The customer responded two kitchens and two bathrooms, however, the other kitchen is barely used at this time. Sue Carpenter requested these charges be taken off her bill. Mayor Cox explained that the Water Committee will be reviewing the current Water Law and that a final determination in the near future could affect future billing.
