Visitor's Forum

Tamara Adams proposed the large pine tree located on Village of Nunda property at the Village Well Site, be removed. Ms. Adams stated she is looking at having a pool built on her property. A. Police Rules of Conduct - A copy of the Police Department - Town and Village of Nunda, New York – Duties and Rules of Conduct has been provided to all Board members.

B. Establish uses for General, Water and Sewer Equipment Reserve Accounts

Resolution no. 2016-066

BE IT RESOLVED, that pursuant to Section 6-c of the General Municipal Law, as amended, there is hereby established capital equipment reserve funds for the General, Water and Sewer Funds. The

purpose of these opened Equipment Reserve Fund Accounts, through resolution dated May 11, 2015, is to accumulate moneys to finance the cost of types of equipment utilized within the appropriate fund(s). The type of equipment to be financed from these Equipment Reserve Fund Accounts is for the acquisition of any equipment with a useful life to be used for the purposes of within said fund(s), as directed by the governing board.

The chief fiscal officer is hereby directed to deposit and secure the moneys of these Reserve Funds in the manner provided by Section 10 of the General Municipal Law. The Nunda Village Board of Trustees may invest the moneys in the appropriate Equipment Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Village of Nunda. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the specific Equipment Reserve Fund. The chief fiscal officer shall account for the Equipment Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Equipment Reserve Fund.

Except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund has been established. No expenditure shall be made from this Reserve Fund without the approval of this governing board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 4 of Section 6-c.

The motion was made by Trustee Morgan, seconded by Deputy Mayor Amrhein. Carried 4-0.

C. Invest \$100 for a beautification project for the Nunda Government Center. The funds will be used for the purchase of flowers, plants and hanging baskets. The project will be in coordination with the Town of Nunda, local Rotary and local students from Keshequa Central School.

Resolution no. 2016-067

BE IT RESOLVED that the Nunda Village Board of Trustees authorizes the expenditure of \$100.00 for the coordinated beautification project through the Village of Nunda, Town of Nunda and local Rotary for the Nunda Government Center.

The motion was made by Deputy Mayor Amrhein, seconded by Trustee Snyder. Carried 4-0.

D. Snow and Ice equipment rental to be moved into the Snow and Ice Equipment Reserve Fund **Resolution no. 2016-068**

BE IT RESOLVED that the Nunda Village Board of Trustees approves the transfer of all revenues received in 2016 through the New York State Snow and Ice Voucher Program for the specific item - Equipment Rental - to be moved into the Snow Equipment Reserve Account. The motion was made by Deputy Mayor Amrhein, seconded by Trustee Snyder. Carried 4-0.

E. Village Park - Lease discussion - Use Authorizations (form)

Trustee Allen asked is the Village still maintaining the Village Park? Mayor Cox answered-yes. Trustee Morgan stated the Village should request a lease from the Trinity Church of Nunda. Trustee Allen stated we should have something in place soon. Trustee Allen asked about advertising for use of the Village Park, the current lease, can we be included in the sponsorship? Mayor Cox stated that there currently is no lease in effect.

Trustee Allen stated his concern with advertising for events in a local weekly publication using the Village Park as a place for such events without Village approval. Trustee Morgan stated the Village Park is just a name for the specific location designated as Village Park, not meaning the Village owns the Park. The name is just that "Village Park". Trustee Allen stated the use of the Village Park will have the Village of Nunda as a sponsor for upcoming events.

The Board has approved a letter be delivered to the Nunda Trinity Church requesting an Agreement to Lease. This correspondence will request the Agreement to Lease and that the

lease delivered to the Village Board will be reviewed by the Village Attorney and approved by the Board prior to implementation. The lease will be in effect for one year and be renewed as the Village Board and Nunda Trinity Church of Nunda agree upon.

There also will be a set of rules and regulations set for the use of the Village Park for all to follow. Use of the Village Park will be through an availability process, as set by the Village Board once the Agreement to Lease has been finalized and approved. This approval process for Village Park use will be through the Village Clerk-Treasurer's Office on a first come first serve availability basis, again once an Agreement to Lease has been put in place and approved.
